

In 2022-2023 Spinal Cord Injury Saskatchewan (SCI SK) relocated operations in Saskatoon to improve accessibility for our members and the general public. The post pandemic landscape shows evidence that continual growth demands a wrap round service delivery model for higher level service delivery standards. It's evident SCI SK must initiate innovative strategies in order to develop renewed connectivity for our rural, Northern and Urban clientele. SCI SK is relying on new technologies and utilizing social media platforms to enhance community awareness across the spectrum. The Peer Mentorship Program is a critical tool activated in the rehabilitative phase for our post trauma clientele. The strength of our Mentorship network is the existence of person(s) with lived experiences that possess the skill set of resilience facing a new world of living with a mobility impairment(s). It's a person's family, friends and loved ones that are the benefactor of these experts which guide them towards an empowering journey of independence.

Spinal Cord Injury Saskatchewan is an industry leader in the development of the Canada Disability Act through consultations with our Provincial and Federal partners. The Canada Disability Act continues to gain traction towards a legitimate vehicle for the rights of Canadians with disabilities. The Canada Disability Act will provide much needed monies to complement the implementation of this ground-breaking Federal strategy. The SCI SK 2021-2024 Strategic Plan developed in conjunction with the SCI Sask Board of Directors encompasses this evidenced based innovation for community inclusivity.

The SCI Sask Operations and Service Delivery throughout the 2022-23 fiscal year were guided by the Strategic Plan key result areas of Capacity, Community Linkages; Financial Resource Generation and Sustainability; Indigenous Engagement; and Public Relations and Recognition. The HR Team collectively met to develop and implement specific activities and outputs to ensure all efforts towards achieving the key result areas were undertaken. The HR Team remains at nine permanent members, with six working in Saskatoon and three in Regina. The Financial Review remains stable, however similar to many non-profit CBOs, SCI Sask is challenged to realize greater financial capacity with limited success in solicited grant allocations, sponsorship and donation. SCI Sask delivered two major fund-raising and community awareness events in 2022-23, which are highlighted in this report. After ten years in one location, the SCI Sask Provincial Office relocated to 1705 McKercher Drive, Saskatoon in June 2022.

SCI Sask, as a corporate member of SCI Canada, collaborates, consults and supports several issues of national significance, included MAid, ACA, Disability Benefits and research projects such as Essential Needs and Cellular phone enhancements. This partnership greatly enhances the SCI Sask capacity.

Thank you to the Board of Directors for their governance, and thank you to the HR Team for their diligence.



<u>Truth and Reconciliation Engagement (TRE) April 2022-January 2023</u>

The objectives in the SCI Sask Truth and Reconciliation Initiative:

Improve upon SCI Sask presence/service offerings within Indigenous Communities Collaborate with Indigenous Leaders

Prioritize and incorporate targeted Truth and Reconciliation Recommendations-Call to Action- into the SCI Sask Holistic Culture and Service Delivery

Through the SCI Sask Truth and Reconciliation Engagement Project, a comprehensive resource list inclusive of the seventy (70) First Nations Bands, Tribal Councils, CBOs, and Elders-Knowledge Keepers within Saskatchewan was developed. Through this, the SCI Sask capacity to connect with FN Band Leaders, Health Directors and other Indigenous Leaders was magnified. SCI Sask will continue to identify what primary barriers are experienced by Indigenous people living with disabilities in Saskatchewan. It is known through conversations that many barriers exist for Indigenous people living with a disability, with one key barrier of overall accessibility, resulting in challenges for individuals to achieve an optimum level of independence and remain in one's respective community, preferably surrounded by supports and family.

An extensive resource document "Indigenous Concepts and Legalities" was collated by the SCI Sask TRE Coordinator Joshua Forrest, edited by Launel Scott, and reviewed by Sheldon Krasowski, Director, Research & Archives, Office of the Treaty Commissioner and Ms. Rita Bouvier, Cultural Advisor. The resource document is available upon request from SCI Sask.
